# Some key learnings reported included:

- How to connect with principal stakeholders.
- The board needs to know who its careholders are and govern on their behalf.
- Board gives authority to the CEO for interpretation, board asks are we ready to accept any reasonable interpretation.

### Some initial participant feedback:

• I truly enjoyed all discussions but listening to the multigenerational presentation resonates with me. I not only serve on a board but train boards and often there is conflict between seasoned members and newly elected members. Very often it is the generation gap. I woke this morning reflecting on my personal leadership and my training sessions. I am rethinking how I will be moving forward to help others embrace the differences the make a great impact in the work they do. My second takeaway was to govern with impact and what that will look like for me as a board member and for those I train. I am definitely rethinking how to approach my actions as a participant and as a trainer of very entrenched mindsets.

For me, this virtual conference took me from my work but was well worth it.

- What this presentation (re: Board Leader Character) did was get me to reflect and stay grounded on what is important. The importance to be a mentor, remain grounded, respect others but keep the courage to do and take action on what needs to be done.
- Demonstrated how service across various sectors (re: Key Policy Governance Challenges in a Variety of Sector) can all benefit from a well developed Policy Governance system.
- This was a mind blowing session and showed the promise and the perils of using AI to assist boards in policy development and learning about the environments in which boards operate.
